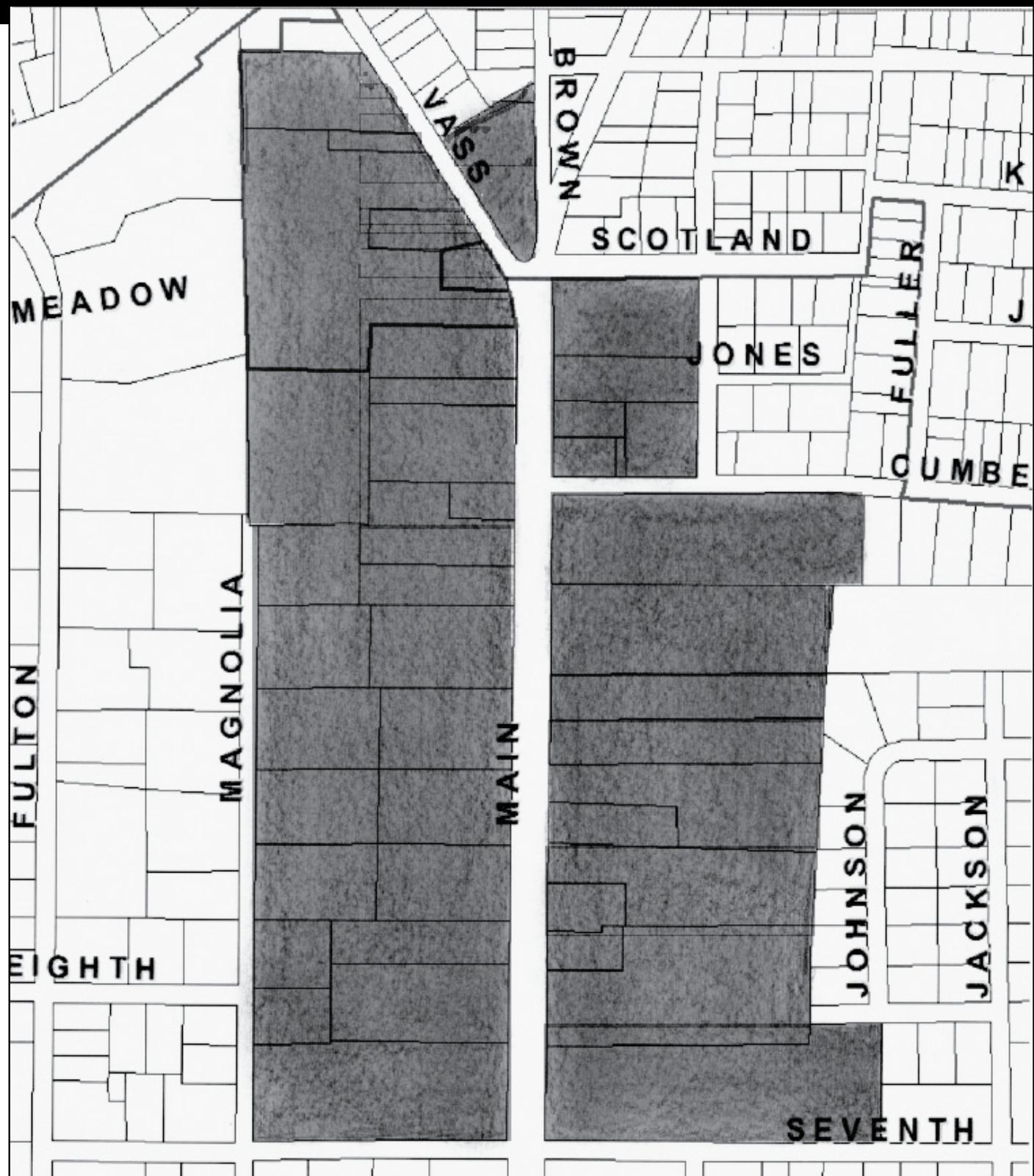

Wetland program deadline approaches

Landowners interested in enrolling their land in a wetland reserve program have until December 19.

That's the deadline to file for fiscal year 2015's ACEP-WRE applications by eligible landowners with their local USDA Service Center. Landowners should contact their local NRCS field office to ensure their farm records are up-to-date, their eligibility forms have been completed, and that they have completed an

NRCS-CPA-1200 to apply for ACEP-WRE.

Although the final rule has not yet been published for ACEP, the WRE component operates like the repealed Wetland Reserve Program (WRP). ACEP-WRE provides financial assistance directly to private and tribal landowners to restore, protect and enhance wetlands on eligible land through the purchase of Wetland Reserve Easements. When the

final rule for ACEP is published, NRCS will notify WRE applicants of any further information or documentation that may be required to process and review the application.

A separate application deadline for the other ACEP components, Agricultural Land Easements (ALE) and ALE-Grasslands of Special Environmental Significance (ALE-GSS), will be announced at a later date.
