



\$175,000 mistake goes to board of adjustment

Planners allow company to open group home in violation of zoning ordinance

Call it a \$175,000 error—a permit apparently mistakenly issued by the county planning department for a group home in the Woodberry subdivision in east Hoke.

A company that operates group homes earlier this year sought and received permission from the county to open one on Woodberry Circle, bought the house, spent \$50,000 renovating it and then was told by planners

that because it's just two doors down from another one—not at least half a mile away as required by the zoning ordinance—it can't be located there.

The error apparently came to light when Gene Shelnutt, whose house is between the two group homes, cried foul. "First of all," he said, "it violates the existing county code. Second of all, would you buy my home knowing it was between two group homes?"

Supreme Court rules against Hoke company

A North Carolina Supreme Court Justice this month upheld a lower court ruling in favor of eight commercial farms claiming that tobacco seed they bought from Hoke County-based Cross Creek Seed was mislabeled, leading to poor results when planted.

The ruling means that the farms are legally allowed to sue Cross Creek Seed for damages under a 1963 state law meant to protect farmers buying agricultural seed for planting.

Superior Court Justice Barbara Jackson decided August 18 to affirm the North Carolina Business Court's April 2016 decision

'Great jobs' coming by year's end, Porter tells chamber

Hoke County business leaders gathered last Tuesday to talk of progress, plans and accomplishments. The Raeford-Hoke Chamber of Commerce Economic Outlook Dinner filled the West Hoke Middle School cafeteria with representatives of the smallest businesses to the largest industries.

Most painted a picture of progress.

Hoke Economic Developer Don Porter, for example, told the crowd that big news is coming, though he wouldn't say what.

"You're going to see some announcements that are just going to cause us to have a great

year in this county," he said. "What we have is...we have started out with a saying that our existing industry is our number one constituent. That's our story and we're sticking to it. And by the end of the year you're going to see some projects that are just bring some more great jobs."


Burlington Industries' new plant manager David Edmundson talked about \$3 million in equipment being invested in Raeford to "keep us sustainable and moving forward and keep us at the top of our industry" in its core work of producing military uniforms for the U.S. government. He also mentioned the company's recent foray into selling yarn. "We decided

about a year ago to really invest in that program and try to grow it and from last year to this year we've doubled our sales, and our forecast for next year is to double that again."

John Miller from Unilever said new technologies are helping the Raeford plant —the world's largest deodorant and antiperspirant manufacturer—to do "more volume than ever."

The entire message wasn't upbeat however. Roxie Wells from Cape Fear Valley Hoke Hospital said that while both of the county's new hospitals are doing well (Cape Fear had 36,000 visitors, she said), citizens should get in touch with state and federal representatives

between State House Districts 48 and 66, represented by Rep. Garland Pierce and Rep. Ken Goodman, both Democrats. The State House's proposed redistricting plan would move Hoke County entirely into District 48, Pierce's district, along with Scotland County. District 66, currently represented by Goodman, would change to include all of Montgomery and Richmond

Smaller state house district proposed for Hoke counties and part of Stanly County.

Pierce said that although as a Democrat he doesn't support the overall redistricting maps as drawn by a majority of Republican lawmakers, creating a smaller district for Hoke and Scotland counties as a consequence could be a good thing.

"We just voted on the House maps and it passed along party lines," he said. "The Democrats feel it's not right but the Republicans feel they've done what the court asked them to do."

Three federal judges last month ordered North Carolina lawmakers to redraw the districts. The panel of judges ruled that 28 districts drawn in previous years were unconstitutional and meant to discriminate against black voters, and must be re-

Redistricting is again a failure

This month, North Carolina lawmakers had a golden opportunity to adopt fair, nonpartisan standards for drawing new legislative voting districts. Instead, they opted for politics as usual, keeping partisanship at the core of a deeply flawed redistricting process.

The General Assembly has been ordered by a federal court to redraw dozens of racially gerrymandered legislative districts. This latest round of redistricting comes roughly 18 months after the legislature faced a separate court order to redraw racially gerrymandered congressional districts. Sadly, this is just the latest in a long line of lawsuits and controversies caused by gerrymandering in our state.

And so, the GOP-led legislature had in its hands a chance to finally end the cycle of gerrymandering by listening to the overwhelming majority of North Carolina citizens who want fair and impartial standards for creating our voting districts. Instead, the Republican majority rejected nonpartisan redistricting criteria, guaranteeing that new legislative districts will be blatantly gerrymandered, just as the old maps were.

That's because the district lines are being manipulated with an eye toward past election results. It's the key ingredient for creating gerrymandered maps that provide maximum advantage to the party in power.

How regrettable.

The truth is that many Republicans, including House Speaker Tim Moore and Senate President Pro Tem Phil Berger, are on the record as supporting nonpartisan redistricting in the past. In fact, Moore and Berger have sponsored nonpartisan redistricting bills nearly 10 times collectively during their careers in the legislature. So what changed?

That answer, of course, is that their party is now in charge of the redistricting process and has the power to gerrymander. And to be fair, when Democrats were in the majority, they ignored all attempts to create a fair redistricting process.

But regardless of which party is guilty of gerrymandering and both parties are – the result has been the same: politicians shielded from accountability, citizens treated like political pawns and voters deprived of a voice at the ballot box.

We the people deserve better. We deserve fairness, rather than partisan political games, on something as important as the creation of our congressional and legislative districts.

For years, Common Cause North Carolina has been an advocate for redistricting reform. We stood shoulder to shoulder with Republicans when they were the minority party championing reform. And today we stand with political leaders, business owners and citizens from both sides of the political aisle who seek a bipartisan solution to gerrymandering.

Last year, we partnered with Duke University's Sanford School of Public Policy to enlist our state's most esteemed retired jurists to produce a sample congressional map without political consideration.

The result was a map that better reflected what North Carolina is: a politically divided, "purple" state. Our jurists were also faithful to the requirements of the Voting Rights Act, resulting in more opportunities for minority representation than the current map drawn by the legislature.

And this spring we worked with Campbell University law students to simulate a nonpartisan redistricting exercise for creating legislative maps. Once again, the resulting districts were more compact and competitive than those created by state lawmakers. The Campbell maps also produced significantly more minority opportunity districts.

While we'd like to hope that lawmakers would draw fair legislative districts, time and again, we've seen legislators instead manipulate voting maps to unfairly favor their own party. It seems that maintaining power at all costs, even by risking costly

litigation, is just too tempting to the party in power, regardless of which party it is.

That's why we the people need to keep the pressure on. We need to demand reform. We need more voices from the right and left. And we need more civic leaders, including local elected officials and members of the business community, to join the cause.

What we demand is a process that is transparent, with true public input. And that means the issue of race must be dealt with where minority voting strength is never weakened by racial gerrymandering.

We demand a redistricting process that is independent, where lines are drawn by someone other than partisan politicians.

And finally, we demand a process that is absolutely nonpartisan, where there is no political consideration looking at past election results, or where incumbents live or how voters are registered.

Last week, North Carolina citizens were provided with a brief chance to weigh in on newly proposed legislative districts. Unfortunately, the proposed districts were released - without important accompanying data – less than 72 hours before the hearing, leaving the public without the tools to fully examine the new districts and how they will impact their communities.

Since that time, it's become painfully obvious that the new maps represent, as many had feared, yet another egregious partisan gerrymander. Now, just days after having ignored repeated demands from hundreds who testified that they head back to the drawing board, lawmakers are poised to pass these maps into law.

The bottom line: Yet again, state lawmakers have dropped the ball when they rejected the chance to draw fair voting maps and instead perpetuated the decades-old cycle of gerrymandering in North Carolina. It was a tragic mistake and one that may come back to haunt them in the not-too-distant




My question is do you as a



that limited any damages to the purchase price of the seeds. If a farm bought the seed and had a problem with it, Cross Creek Seed was only liable for the purchase price of its seeds, the defendants believed.

However, Jackson found that the limitation of remedies clause couldn't be enforced because it conflicted with the state's Seed

The legal case has gone through over two years of procedures. In July 2015 the Chief Justice of the North Carolina Supreme Court designated the lawsuit a mandatory complex business case, and the eight separate suits were combined into one "master file" under plaintiff Kornegay Family Farms name. In October of that year, attorneys for Cross Creek Seed asked the court for partial summary judgment against the eight farms "seeking to bar recovery of any damages exceeding the purchase price of the seed," according to court documents.

The court declined that request and also declined subsequent requests. Court officials referenced a similar 1971 court case, Gore v. George J. Ball, Inc., which involved tomatoes instead of tobacco.

"Although the Seed Law is regulatory in nature, it does not bar aggrieved parties from pursuing private, civil litigation for damages resulting from mislabeled seed. In fact, certain provisions of the Seed Law clearly demonstrate that the General Assembly contemplated such recourse," Jackson wrote in the ruling.

The court documents did not describe a total amount of money that the eight plaintiffs may seek in the civil case from Cross Creek Seed.

Attorney Steve Epstein of Poyner Spruill LLP, the firm that represented Cross Creek Seed, declined to comment on the matter.

"We're not going to have any comment," he said.

Phone calls to the Ellis and Parker PLLC law firm, which represented the plaintiffs, were not returned by News-Journal deadline.

Cross Creek Seed was founded more than 50 years ago and has shipped seed to countries around the world, with as much as a third of the company's business dedicated to international trade. As of 2015, the company held upwards of 40 or 45 percent of the United States tobacco market for tobacco seed sales.





On Thursday, Shelnutt sat on his front porch near the entrance to the subdivision—at the spot where he estimated 15 to 18 people were to protest the home that afternoon. The protest was called off a few hours earlier, he said, because organizers learned of a possible counter-protest.

"We didn't want anything that would cause a confrontation and it be made something that it's not. We're not protesting Mr. McNeill; we're not protesting the people that he helps; we're protesting the violation of Hoke County's zoning code," he said.

Darrin McNeill, to whom Shelnut referred, is the CEO of Serenity Therapeutic Services, the company that is seeking to open the home.

McNeill says he had permission on two occasions to open the home. "It wasn't until I was told I could put my facility here—twice—and I purchased the home and I started to make renovations to the home that I was told, 'oh, you can't put one here."

His account is not disputed by County Planning Director Robert Farrell. "It was a permit that was issued in error," Farrell said. "We consulted with our county attorney;

it was determined that we would be able to rescind that permit, which was done. He said the matter has been appealed to the board of adjustments, which will hear the case Oct. 5.

McNeill says he has nothing against Shelnutt or others in the neighborhood, but he has operated according to the rules. "I followed the procedures—the policies and procedures—for the county to open a facility.

"I've been in the business for almost 20 years. I have six facilities in Hoke County. This is not my first time starting a group home. I've done this for a long time," he said.

"If the county has that big an issue, fine, it was your mistake; own up to it, I'll give you the amount I paid to purchase the home, and the amount I spent on renovations. The county—Idon't care who—him, the county, don't matter. Pay me, and I'll move. I'll find somewhere else to go.

"This is a \$175,000 mistake. We're not talking about some change. We're talking about \$175,000 that I've spent. And anyone who wants to give me \$175,000, I'll move tomorrow.

"Allow me to do what you told me I could do twice, or buy me out."

Meanwhile, McNeill says, he has two residents—one in a wheelchair—who are becoming homeless because of the issue. He'd already made plans to move them into the house, and now can't. With a 30-day grace period given by the owner of the house where the two currently reside, he has until September 15 to find new accommodations for them.

"They will be homeless. And it's not fair to them," he said. "Forget me, the company and everything else. And even the neighbors here who have issues. We have two human beings who have disabilities who will be homeless if the county can't fix it."

Hoke County's zoning ordinance refers to group homes as family care homes. Among its requirements, the ordinance requires:

- they be constructed as singlefamily houses.
- they not located within a halfmile radius of another.
- those providing primary services to residents must live in the
- the house not have outdoor signs or advertising
- the house not have additional parking.

• the house not create additional traffic, congestion, noise, vibration, odor, glare, fumes or electrical or communication interference.

By definition the homes are for adults and may have two to six

The half-mile radius specified by the ordinance is reflective of state law, which forbids local governments from requiring special use permits or variances from zoning law in the case of group homes, but allows the half-mile separation.

Anti-discrimination cases in courts across the U.S. have sometimes overturned regulations that limit the separation requirements for group homes, but in a couple of cases in North Carolina the half-mile requirement was upheld.

(Continued from page 1) worked. The judges did not call for special elections, but ordered that the state approve and put in place the new district maps by September 1.

There is still ongoing debate on the boundary lines and the judges will have the final word on the issue, Pierce said.

However, a two-county House district for Hoke and Scotland would be "ideal," the state representative said.

"It's just a win-win for those two counties, so I can't argue that point," he said.

Currently Hoke is split into two larger districts including Montgomery, Richmond, Robeson and Scotland counties in District 66 and Richmond, Robeson and Scotland in District 48.

A smaller district will allow the elected state representative to focus more time and attention on Hoke and Scotland counties, and based on the population estimates a Hoke-Scotland district would be "ideal," Pierce said.

Goodman, who represents District 66, would also see his district shrink from five to three counties under the redistricting plan.

State Senate maps The proposed senate maps, change Hoke County's State Senate district. State Sen. Ben Clark represents all of Hoke County and part of Cumberland County for District 21.

However, a proposed change in the map in Cumberland County would extend the boundary line about five miles in a sliver of land to include a house Clark owns located just outside his district. The house is in State Senate District 19, which is currently represented by Sen. Wesley Meredith, a Republican.

Clark's original residence is located in Hoke County, in his own district, according to public records. Members of the General Assembly must live in the district they represent for at least a year before running for election, according to the North Carolina

Records show that Clark voted Monday, according to reports.


